#### Release Announcement

This hotfix of ERAD RIS 4.2023.057.2 enhances the ability of RIS to integrate with billing systems such as Imagine Simplicity.

#### **New Features**

## FEATURE DETAILS

### **Billing**

#### Feature #37422 - Imagine Simplicity Integration

#### Summary

This enhancement to Billing introduces a service tool that enables the ability to submit requests through Imagine Simplicity, offering a streamlined alternative to Availity and other eligibility services.

#### **Background**

As more customers connect to a variety of insurance systems, the eligibility process needed greater flexibility. This update introduces a way to route eligibility checks based on payer, helping reduce integration complexity and improve support for different insurance platforms.

#### Feature Description

The new Ansi270Genericws Web Service allows customers to customize how eligibility checks are handled, based on the insurance provider. It supports integration with systems like Availity and Simplicity, and automatically routes requests using the Payer ID. This makes the eligibility process more flexible and easier to manage when working with multiple insurance networks.

#### Service Team Upgrade Instructions

The Service Team must complete the following actions to deploy this feature:

#### 1. Configure the Ansi270 Web Service

- Open the Ansi270WebService.exe.config file.
- Set the **IP address** and **port** where the web service should listen for incoming requests.

#### 2. Update eRAD RIS Core Service Configuration

- Open the RISServicesx64.exe.config file in the **eRAD RIS core services** directory.
- Replace the current hostname and port for the Ansi270 endpoint with the values you configured in Step 1.

#### 3. Apply Imagine-Specific Configuration

- Navigate to the folder where the Ansi270 Windows Service is deployed.
- Open the Ansi270WebService.dll.config file.
- Update any configuration sections that are specific to **Imagine** (e.g., customer-specific settings or integration parameters).
  - o These values should be provided in the Imagine-specific config package or documentation.


