# **SUMMARY**

### Release Announcement

This release of ERAD RIS 4.2023.009 introduces changes for configuring workflow and user preferences in the Provider Portal.

### **New Features**

This release introduces the following features and enhancements:

## **FEATURE DETAILS**

### **Provider Portal**

### Feature #31662 – Allow All Staff User for a Provider Access to View Orders Pending Approval

### Summary

This enhancement to the Provider Portal allows all staff users to view orders in a pending approval status to permit for visibility.

### Feature Description

Previously, orders in a pending approval status were only viewable to the Provider and the Staff User that created the order. As a result, duplicate orders were being entered in the system.

With this change, all staff users that are listed under the referring physician will have the ability to view orders that are pending approvals/UM Pending Review on the Pending tab. Users will also have access to add attachments while the order is in a pending approval status.

In addition, a new Requested By filter criteria option has been added to the Pending Order tab for referring users. However, when logged in as a staff user, this filter criteria will be removed so all associated staff can see pending orders for the selected referring and any affiliated referring users.

### Feature #32683 – Update Access Options for Staff Users in both Referring and Admin Portal

### Summary

This enhancement to the Referring Portal and the Admin Portal updates the access options given to staff members when creating orders.

### Feature Description

Previously, read only was not an available access option for staff user account creation.

With this change, a third access setting will be introduced to give staff users a No Order Access (ReadOnly) option.

The wording of the existing choices has also been updated:

- No Order Access (Read Only)
- Create Pending Order (Needing My Review)

• Create Full Order (My Review Not Required)



The default setting for new staff users will now be No Order Access (Read On(y)).

### **Known Limitations**

While there are no Known Limitations for this feature, there is additional functionality planned for a future release that will change the implementation approach, and is expected to impact how this feature will be configured:

# Feature #32696 – Allow Staff users with Review Required permissions to edit/cancel pending orders

### Summary

This enhancement to the Referring Portal provides Staff users with accessibility to edit or cancel pending orders.

### Feature Description

Previously, Staff users with Review Required permissions did not have the access to make these changes to a pending order.

With this change, staff users with the updated <u>Create Pending Order (Needing My Review)</u> permissions will now have ability to edit or cancel orders that are currently pending under the following conditions:

- The staff user is viewing for a referring that is associated to the requesting referring and requesting address.
- The staff user is associated to the requesting referring through a proxy or affiliation.
- The staff user does NOT have Read Only permission for requesting referring.
- The staff user does NOT have a location exclusion for the requesting address.
- The pending order is NOT a UM case.

Staff with location exclusions for the requesting address will be treated similarly to staff with Read Only permission.

Additionally, the edit and cancel icons have been added to the Pending tab and the Order screen in the patient account.

### Feature #32840 – Remove Location restriction from Referring Order Preferences from Referring Portal and Admin Portal

### Feature Description

This enhancement to the Referring Portal and the Admin Portal removes the location-level restriction for creating orders from user's Account Settings options.

Previously, when configuring staff users to have the ability to create orders with or without review, the location was a criteria to choose from. This was causing issues when new locations were added to RIS, as the settings were not moving over to the newly added locations.

With this change, the location level settings option will no longer be a criteria to choose from in the Account Settings on the Orders tab.



Upon upgrading, any existing users with established Wo Review Required permissions will now have access to all current and future locations.

# Feature #33308 – Add Referring Physician Location Exclusion to Staff User Settings

### Summary

This enhancement to the Referring Portal and the Admin Portal adds the ability to add location exclusions for Staff users.

### Feature Description

Previously, when adding a new Staff user, the user would not inherit existing settings that were affiliated with the referring such as locations. This behavior was removed in FEATURE #32840 – REMOVE LOCATION RESTRICTION FROM REFERRING ORDER PREFERENCES FROM REFERRING PORTAL AND ADMIN PORTAL.

With this change, users will now have access to all locations by default, unless specially excluded using this new setting.

### **Referring Portal Changes**

The existing Orders tab has been renamed to Staff Settings to accommodate the changes.

Additionally, a new collapsible Staff Location Exclusions section has been added between the Default Ordering Provider and Authorized to Order sections.

Exclusions restrict patients seen from the listed location on both the Home and Orders tab. To view patients seen at excluded locations, the staff user will need to perform an out of practice search.

Note that if the referring is the staff user's proxy and adds an exclusion, this will also remove access for all other affiliated physician's patients at that location.

If the referring is the staff user's non-proxy and adds an exclusion, this will only remove access from their patient's at that site.

- 1. Staff User drop down values display the logged in Physician, Proxy user and users of logged in Physician affiliated users.
  - a. Searching for staff user by username is permitted.
- 2. Current access values are based on the Physician that is logged in.
- 3. Moving locations from Current Access to Exclude will also cause the locations to display in the Exclusions field at the bottom of the screen.
  - a. Access to those locations will also be removed for Physician that is currently logged in.
- 4. Checking one or more locations from Exclude to Current Access will add access back.

#### **Admin Portal**

Under the individual staff user and the Referring Physician account:

Within the existing Proxy and Affiliations tab, a new Staff Location Exclusions section has been added.
