SUMMARY

Release Announcement

This rapid release of ERAD RIS 4.2024.008.0.2 addresses a security issue and merges the content of ERAD RIS 4.2024.008.0.1, which introduces the ability to bypass Insurance for Mobile Workflow and resolves a URL site group parameter issue.

New Features

This release introduces the following feature, merged from the uncommercialized ERAD RIS 4.2024.008.0.1 release:

FEATURE DETAILS

Patient WF: Make Appointment

Service-Only Feature #35017 – Ability to bypass Insurance step for Mobile Workflow

Summary

This enhancement to Patient WF: Make Appointment introduces the capability to bypass the insurance step within the Mobile workflow.

Background

In certain instances, a third party may assume financial responsibility for certain exams so it is not necessary to present the patient with insurance-related inquiries at the time of service.

Previously, the scheduling workflow could be updated to bypass the insurance step via the existing ScheduleWorkflow configuration option, but this would disable it for all workflows, not just mobile.

Feature Description

With this change, a new <u>showInsuranceStep</u> URL parameter has been created to allow the insurance step to be suppressed within the mobile workflow.

Service Team Upgrade Instructions

The Service Team must complete the following actions to deploy this feature:

Portals

Changes to applicationsettings.config

- To bypass the Insurance step for Mobile Workflow, add the ?showInsuranceStep=False parameter to the mobile mamo URL.
 - e.g.:

http://{patient portal URL}/Mobile/{site group}/{start date}/{end date}/?showInsuranceStep=false

- Default is True and functionality is unchanged is upon upgrade.
- Alternatively, to configure all workflows (not just mobile workflow) to bypass the insurance step, update the existing <u>ScheduleWorkflow</u> configuration to remove <u>InsuranceStep</u> from the list of comma-separated values.


