The hotfix and rapid releases 3.2018.5.4.0.1, 3.2018.5.4.5.1, 3.2018.5.4.8, 3.2018.5.6.1.1, 3.2021.6.7.1.1, 3.2022.6.20.0.1, 3.2022.8.29.7, 4.2022.10.24.4.1, 4.2023.030.1, 4.2023.043.1, 4.2023.057.1, and 4.2023.076.1 address a security issue.

New Known Limitations

The following new Known Limitations were identified that affects the ERAD RIS 3.2018.5.4.0.1 THROUGH 4.2023.076.1 releases (as well as the ERAD RIS 4.2024.011 release):

- BUG #35113- NO PROVIDERS FOUND WHEN MAKING AN APPOINTMENT OUTSIDE OF LOG IN
 - **Issue**: With the security fix hotfix in place, searching for a provider no longer returns any results in the guest appointment workflow.
 - **Impact**: When a patient who is not logged in (the guest appointment workflow), the provider search will not return any results, however they must make a provider selection to proceed.
 - **Workaround**: Patients that are logged in do not experience this limitation. Alternatively, they may select the **Provider Not Listed** option.



Carefully review all Known Limitations identified here and in the release notes of all other versions being applied and communicate relevant items to all those affected.
