### Feature Description

Previously, there was no user messaging to make a referring physician aware when they had pending orders that they were required to sign.

With this change, a new section in the Referring portal account and Admin user search edit pages has been created to enable notification:

Users may configure their desired communication frequency, either As Created to be notified immediately when a pending order is created, or Daily, to only receive a summary notification with a count of pending orders at a desired time:

A new StartReferringProviderPendingService service will poll each hour for any pending orders.

Note that if portal server communication fails, the system will send a generic formatted email to the referring to ensure no notifications are missed.

#### **Configuration Instructions**

System Administrators must complete the following actions to enable this feature:

#### Web Services

For the daily notification process, a new service was added to wcfservice to enable or disable an hourly poll for any referring doctors with pending orders.

The scheduled sending process will use the site group configuration value for AutomatedEmailAddress, or if this is not set, will use the new value for

ReferringProviderPendingServiceAutomatedEmailAddress.
