Feature #33840 - Enhance Group Name criteria to use the co_insurance in the plan vs service type section

Summary

This enhancement to Insurance Eligibility updates Eligibility SQL filters to allow exclusion of line items based on source and level values, allowing rules to e.g., exclude all "service_type" level co-insurances when performing Amount to Collect calculations.

Feature Description

With this change, the Eligibility Special Conditions Table "Edit SQL" filters now allow exclusion of line items based on:

- Source values such as "service_type", "plan"
- Level values such as "Family", "Individual", "Employee"
