# SUMMARY

## **Release Announcement**

This release of **ERAD RIS 4.2024.044** updates Insurance Eligibility to provide more accurate eligibility response calculations.

## New Features

This release introduces the following features and enhancements:

Insurance Eligibility	35124	Include Out Of Network values in JSON	This enhancement to Insurance Eligibility updates JSON encoding to include financials for out-of-network values, necessary for calculating the patient financial responsibility amount.

## **Resolved Issues**

This release resolves the following issues:

Category	Redmine #	Subject
Insurance Eligibility	34972	Resolved Insurance Eligibility issue that caused the 271 eligibility response to return a parsing error.
Insurance Eligibility	35080	Resolved Insurance Eligibility issue where the 271 eligibility response returned the premium end date rather than the plan end date as expected.
Insurance Eligibility	35179	Resolved Insurance Eligibility issue where the 271 eligibility response for expired plans returned an error rather than an inactive message alert.
Insurance Eligibility	35233	Resolved Insurance Eligibility issue where the transformation from 271 to JSON format was not correctly parsed for some carriers.

# **Insurance Eligibility**

## Feature #35124 - Include Out Of Network values in JSON

### Summary

This enhancement to Insurance Eligibility updates JSON encoding to include financials for out-of-network values, necessary for calculating the patient financial responsibility amount.

#### Background

Previously, an under-collection would occur on exams where a higher out of network copay was the accurate amount to collect. This was due to RIS not recognizing the copay amount which returns as an "N" in the JSON and XML.

### Feature Description

This enhancement to Insurance Eligibility updates the X12 271 to JSON transformation to include financials for out-of-network values (i.e., where  $\boxed{EB12} = \boxed{N}$ ).
