SUMMARY

Release Announcement

This release of ERAD RIS 4.2024.068 updates the configurability for the display of the Authorization Code field within the Patient Portal.

New Features

This release introduces the following features and enhancements:

FEATURE DETAILS

Patient WF: Make Appointment

Feature #34986 – Only show Authorization Code field for required procedures

Summary

This enhancement to Patient WF: Make Appointment adds configurability to the authorization code field and related padding rules within the Patient Portal.

Background

Previously, the authorization code field was displayed for all procedures during scheduling, lacking the ability to configure its visibility solely for procedures requiring authorization. Additionally, these changes have been made to decrease the number of prompts presented to the user.

Feature Description

With these changes, the authorization code field within the insurance step will be displayed based on the configured authorization rules within the PreCert Rules lookup editor.

Padding

New configurable padding rules allow configuring the number of hours before a patient can proceed to schedule via the portal:

- If authorization is required, the field will be visible, but a value will not be required.
 - If an authorization code is *not* entered padding will be applied via
 PPAuthorizationRequiredNotPopulatedHourPadding
 - If an authorization code is entered, scheduling will be permitted, and padding will be applied via
 PPAuthorizationRequiredPopulatedHourPadding
- If authorization is not required, the field will not be visible, and padding will be applied via PPAuthorizationNotRequiredHourPadding if a value is configured.

Note, if the insurance selection step occurs before an exam is selected, then the authorization code field will be presented by default.

Configuration Instructions

System Administrators must complete the following actions to enable this feature:

Changes to ProcedureCode Lookup Table

- Enable PP Require Authorization Flag for desired procedure code.
 - When enabled the system will reference this column to check if authorization number is required prior to running a validation check on the PreCert Rules table for the associated procedure code.

Changes to SystemConfig Lookup Table Settings

- Configure PreCert Rules for desired Carrier within the PreCert Rules lookup table.
- Enable PP Require Authorization Flag in Procedure Code table.
- Set padding days via the newly added system configurations
