## SUMMARY

### **Release Announcement**

This release of ERAD RIS 4.2024.087 introduces an Insurance AI update which allows for Image Recognition on previously scanned insurance cards.

## FEATURE DETAILS

### Insurance AI

# Feature #35437 - Image Recognition for Existing Scanned Insurance Cards

### Summary

This enhancement to Insurance AI adds the ability to perform Image Recognition on existing insurance cards to automatically update the information in the Managed Policies grid.

#### Background

Previously, RIS utilized image recognition data for newly added insurance cards but did not have the capability to perform image recognition on previously scanned insurance cards. This required users to manually review and confirm information for established patients not presenting an insurance card during their visit.

### Feature Description

With this change, when ImageRecognitionInsuranceCardPriorDaysCutOff is configured, the system will look for previously scanned insurance cards and automatically update the information in the Managed Policies Grid.



Note this feature must be disabled when *Historical Carrier Selection* is enabled as to not override that functionality.

### **Configuration Instructions**

System Administrators must complete the following actions to enable this feature:

#### **RIS Client**

#### Changes to SystemConfig Lookup Table

- **Configure** ImageRecognitionInsuranceCardPriorDaysCutOff for your installation.
  - Confirm Historical Carrier Selection is disabled to use this feature.
  - The default value leaves existing system behavior unchanged.

The following related settings were added or updated:

Setting	Default	Purpose
ImageRecognitionInsuranceCardPriorDaysCutoff	Value=Days as Integer, Set to [-1] to disable, Default=[-1]	Number of days back that RIS will look for prior insurance card to use for default carrier selection based on Image Recognition. Disable when using Historical Carrier Selection functionality. Updated by #35437
